## Matters Arising

## Advance Motorist Speaker

The President advised that she had contacted Clive Tong and confirmed that the Advanced Motorists are a charity so that we can work with them.

## Co-option of Additional Committee Members

The Chair proposed that to strengthen the Committee, especially with the Vice-Chair position being vacant, the Committee should invoke it's right to co-opt two additional Committee Members with full voting rights for a period of one year, i.e. until the A.G.M. in April 2016. This proposal was seconded by Brian James and carried unanimously by those present and by emails from the three absentees.

Eileen Ducker and Ian Smith were duly co-opted to the Committee to serve for one year.
The President suggested that the Membership Secretary and the Admin Assistant should be invited to some Committee meetings to familiarise themselves with the conduct of the Committee and to get to know the Committee Members.

The Chair confirmed that she intended to invite both of these and going forward would seek to invite relevant members as observers at Committee meetings.

## Action:

Secretary to issue invitations to Membership Secretary and Admin Assistant and other members as instructed by the Chair.

## Schedule of Meeting Dates 2015-16

The Secretary had issued a revised schedule of meeting dates for the coming 12 months. It was agreed that all Committee Members would not be able to attend all meetings; acceptance of the schedule was proposed by the Secretary and seconded by lan Snape and agreed by all.

## Paid Tutors

The Chair advised that she would like to finalise the guidance on using paid tutors. She said that there was a question on whether Ballroom Dancing would continue in the Autumn but if it did the Group Leader had agreed that it would do so in accordance with the agreed regulations.

Ian Snape suggested that the Inland Revenue questionnaire be revisited to produce a numbered outcome stating that each tutor was self-employed.

The Chair informed the meeting that she would be revising and reissuing the Group Leaders' Handbook in time for distribution at the Group Leaders' Get Together on $12^{\text {th }}$ June and that this would include the page of guidance on using paid tutors. She said she would like the Committee to approve the Handbook before it was sent for printing.

## Action:

## Membership Secretary

The Secretary informed the meeting that a new member, Moira Laverack, had volunteered to undertake the full role of Membership Secretary, including organising New Members' meetings and attending drop-ins
